- Please complete the information on your application within the spaces provided. **Do not submit attachments instead of completing the application form.** If you require additional space, please ensure that you complete the most relevant information in the spaces provided and then you may attach further details.
- Please attach your application together with a paper clip or 'magic clip'. Please do not staple your forms.
- Do **not** submit this information page with your application form.

**Supporting documentation**

- You are required to provide documentation in support of this application. If you do not attach all of the documents required by the Faculty, your application may not be considered. There is information on the application form about the other documentation which you must provide. The documents you must provide include:
  - \* proof of change of name, if applicable
  - \* evidence of your residency status
  - \* information about your record of exclusion, if applicable
  - \* evidence of English proficiency (only IELTS is accepted, requiring a minimum overall score of 7), if applicable
  - \* academic transcripts for your qualifications
  - \* evidence of Australian Psychological Society (APS) assessment of non-Australian qualifications, if applicable
  - \* two referee reports in confidential signed and sealed envelopes
- You should try to provide originals wherever possible, especially of academic documents such as transcripts and IELTS English test result notices. Faculty and Student Centre staff can sight original documents and copy them for you so that you need not submit originals with your application. If you have questions about which types of documents are acceptable in support of your application, or whether or not original documents can be returned to you after your application has been processed, you should contact the Faculty.
- If your supporting documents are not in English you must provide translated versions of those documents in addition to certified copies of the originals. These translations should be official. Some examples of the types of translations which may be accepted are those produced by the Ethnic Affairs Commission (EAC), the Department of Immigration, Multicultural and Indigenous Affairs (DIMIA), or by an accredited National Accreditation Authority for Translators and Interpreters (NAATI) translator of at least 'Translator' or 'Level 3' status. Please note that if you are providing copies of translations, rather than originals, those copies must also be certified.
- When providing academic transcripts from other Universities or institutions, please include the document which outlines the grading or scoring system, eg. categories, class of honours, GPAs.
- Please provide the overall result you obtained for your fourth year only as a mark out of 100. Please contact your fourth year coordinator to obtain this result if it is not recorded on your academic transcript.
